- **Package Management Fee includes:** Ongoing organizational activities associated with ensuring the smooth delivery and management of your home care package.

- **GST:** Rates are GST exclusive. GST is charged at the rate of 10% where applicable. Generally, most services are GST-free, except for materials, and third-party products, services and consumables.
- The fees and charges specified above will change with effect from 1 July each year by the greater of 5% and the percentage change in CPI Melbourne for the prior period 30 Jun to 1 July, unless we notify you that a reduced fee or charge is to apply or we agree to an Alternate Charge. Each year we will provide you with a revised Standard
